Research Student Application Guidelines for AY 2024 Autumn Semester

Application Requirements

- Applicants must have a degree equivalent to a bachelor's degree, or be expected to obtain one, or have academic ability equivalent to or higher than the above.
- Those who wish to continue on to our SIT master's degree after completion of the research program.
 - * Foreign nationals must also meet the following conditions.
- Applicants must not have exceeded more than one and a half year as a research student at any other Japanese university, at the time of admission to SIT.
- Those whose level of language proficiency meets either of the following criteria viz. a or b.
- a. Japanese language proficiency: Applicants must have passed the Japanese Language Proficiency Test (JLPT) at the N2 level or above, or have scored at least 200 points on the EJU Japanese as a Foreign Language test (reading comprehension, listening comprehension and listening-reading comprehension).
- b. English language proficiency: Applicants must be recognized as having a B2 level or higher on the Common European Framework of Reference for Languages (CEFR).

■ About Security Trade Control (Export Control)

Shibaura Institute of Technology (SIT) checks them at any case of technology transfers, or the entries of researcher or student based on rules of the Foreign Exchange and Foreign Trade Act and related laws and regulations.

Therefore, you will be required to change the education or research you (will) desire in case it is (will be) possibly regulated.

It does not affect the result of entrance examination.

Application Process and Schedule

Once you have decided on a faculty member whom you would like to be your advisor based on your research plan, please contact the respective student affairs office by e-mail with the following documents attached within the Preliminary Consultation Period.

*In the email, please state why you wish to conduct research with that faculty member and why you wish to be a research student rather than a master's student.

*Please contact the respective student affairs office, not the academic advisor

After reviewing the contents and coordinating with your desired faculty advisor, we will contact you by e-mail before the application period.

After meeting with the faculty member, please obtain informal consent for acceptance and submit your application by the end of the application period.

- 5. University transcripts (original and Japanese or English version)
- 6. Documents proving that the language requirement has been fulfilled (photocopies are acceptable)
